## INFORMATION FOR TRADE & COMMERCIAL EXHIBITORS

**N.B: To comply with Mid Coast Council & WorkCover Policy ALL your electrical equipment and extension cords must have a current electrical certification tag attached or your booking will be denied. Annual safety checks are conducted on site.**

### INDOOR SITES:

There are a limited number of Indoor Sites and as a result, these are generally taken up quite early. The sites are modules of 3m x 3m. All are carpeted and have power available.

The charge for each site is \$35.00 for one (1) day or \$60 for two (2) days, for a 3 x 3 meter module including power.

**For Business/Commercial Stallholders:** Defined as those who are a commercial enterprise and have an ABN. These stallholders **must have their own insurance policy** with a minimum **\$20M** Public Liability cover and provide a copy of their certificate of currency to the Show. They cannot access the Show's public liability in any manner.

**For Hobbyist Stallholders:** Defined as those who are not running a formal commercial enterprise nor have an ABN and they earn under \$20,000 per year from their stall activity. Those Hobbyist Stallholders who meet this definition and have signed the below declaration are automatically covered under the Show's insurance cover for Public Liability. The ASC's Public Liability insurance does not extend to Hobbyists in any manner for any Products Liability exposure.

The sites are let on a first come, first serve basis.

**Payment in full is required with booking application, along with a copy of your current P\L Policy if applicable**

### OUTDOOR SITES:

There are Outdoor Sites available, but a limited number with power and/or water.

The charge for Outdoor Sites is \$60.00 for one (1) or \$100 for two (2) days, for a 4 meter frontage site including power.

**For Business/Commercial Stallholders:** Defined as those who are a commercial enterprise and have an ABN. These stallholders **must have their own insurance policy** with a minimum **\$20M** Public Liability cover and provide a copy of their certificate of currency to the Show. They cannot access the Show's public liability in any manner.

**For Hobbyist Stallholders:** Defined as those who are not running a formal commercial enterprise nor have an ABN and they earn under \$20,000 per year from their stall activity. Those Hobbyist Stallholders who meet this definition and have signed the below declaration are automatically covered under the Show's insurance cover for Public Liability. The ASC's Public Liability insurance does not extend to Hobbyists in any manner for any Products Liability exposure.

The sites are let on a first come, first serve basis.

**Payment in full is required with booking application, along with a copy of your current P\L Policy if applicable**
